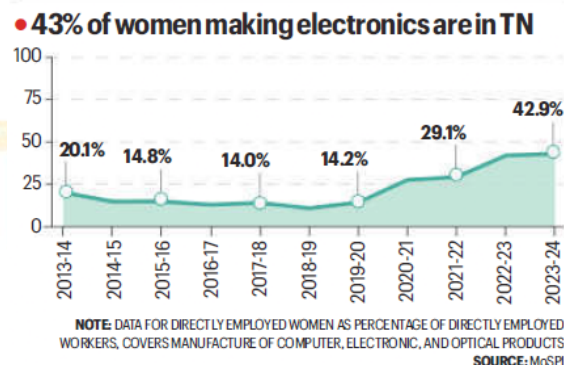

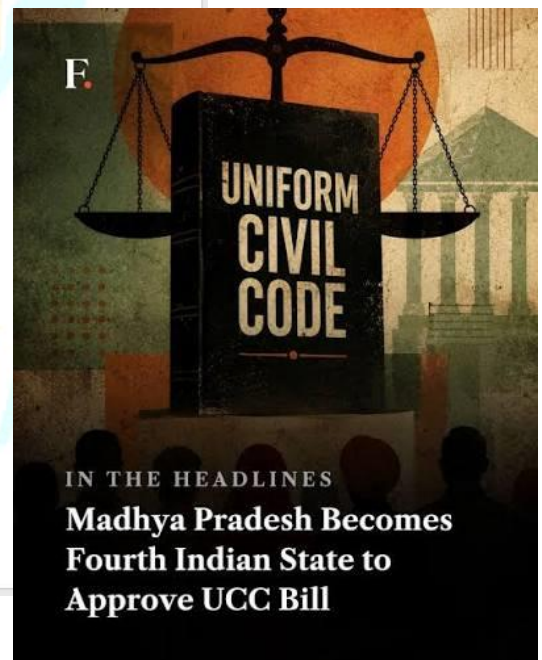

8. Education's Declining Share in Union Budget Over Twelve Years

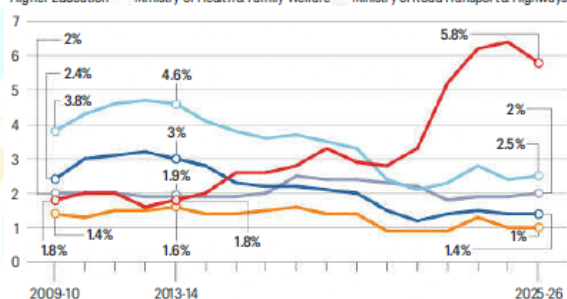

- **Skill Development Allocations:** Despite the emphasis on the Skill India initiative and artificial intelligence integration, the budgetary share dedicated to the Ministry of Skill Development and Entrepreneurship remained minuscule, hovering around 0.05% to 0.06%.
- **Systemic Examination Crises:** Widespread public scrutiny and protests at Jantar Mantar underscored administrative accountability issues, driven by recurring competitive examination paper leaks affecting millions of job aspirants over the past decade.
- **Long-Term Human Capital Implications:** Economists and policy experts warn that sustained under-investment in public education risks compromising India's demographic dividend and long-term socio-economic productivity.

9. IISc's Novel Ultrasound Method Holds Promise for Oral Cancer Treatment

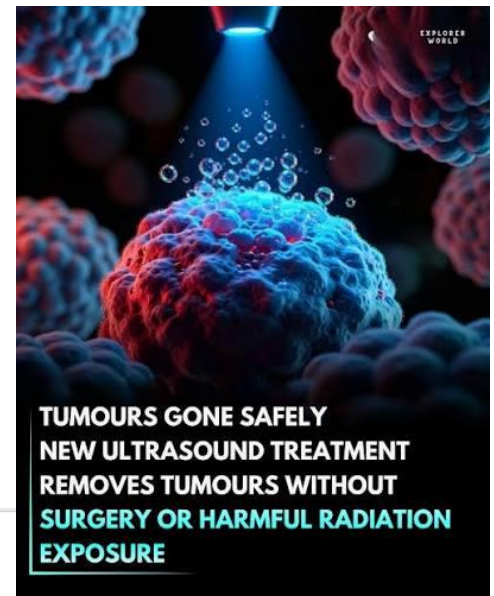
Key Highlights and Summary

- **Breakthrough Research:** Researchers from the Indian Institute of Science (IISc) in Bengaluru, in collaboration with M S Ramaiah Medical College, discovered potential applications of lowfrequency ultrasound (LFU) mechanostimulation in treating oral cancer.
- **Vulnerability of Cancer Cells:** Using a 3D co-culture platform mimicking tumor environments, the study found that oral cancer cells are selectively vulnerable to LFU due to lower levels of the protein Tropomyosin 2.1, while normal cells remain largely unaffected.
- **Prevalence in India:** Given the widespread use of chewable tobacco products, oral cancer is a major health crisis in India, accounting for nearly 1/4 of all global cases with a lower five-year survival rate compared to developed nations.

- **Targeted Advantages:** Unlike High Intensity Focused Ultrasound (HIFU) which generates heat to burn cells or traditional surgical interventions, the non-invasive LFU approach minimizes thermal side effects and damage to healthy surrounding tissues.
- **Broader Therapeutic Potential:** The novel technique could eventually be expanded across other superficial cancers like breast cancer and melanoma, offering a cost-effective and easily monitorable treatment alternative.

10. First Sanctions, Now War: India's Chabahar Port Plans Up in the Air

- **Budgetary Repercussions:** Amid mounting geopolitical headwinds and the expiration of waivers, the Union Budget for 2026-2027 made no direct financial allocation for the Chabahar project, leaving its immediate future hanging in the balance.

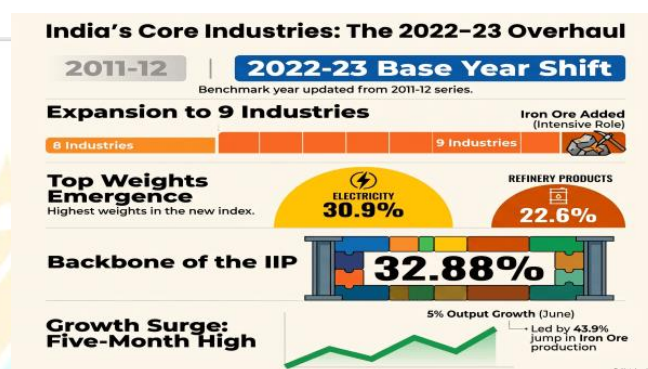
