1. Supreme Court Verdict on 'Industry' Definition under Industrial Relations Code, 2020

Key Highlights & Summary

- A nine-judge Constitution Bench of the Supreme Court, headed by Chief Justice of India Surya Kant, held that the expansive 1978 definition of 'industry' will not apply to the new Industrial Relations Code (IRC), 2020.
- The ruling overrules the precedent set in the 1978 *Bangalore Water Supply and Sewerage Board v. R. Rajappa* case, which broadly extended labor protections across diverse sectors.
- Under Section 2(p) of the IRC, 2020, the interpretation of 'industry' will now be based strictly on its own text and context, starting from a clean slate without past burdens.

- The court clarified that the prospective application of the 'refined' triple test means the 1978 judgment's triple test will continue to apply to pending industrial disputes.
- The 1978 verdict had previously brought educational institutions, hospitals, and municipalities within the ambit of 'industry,' granting workers broad collective bargaining rights.
- The new ruling safeguards the legislative intent of the IRC, 2020, balancing employee protections with administrative flexibility and functional autonomy of institutions.

Conclusion

The Supreme Court's verdict marks a major shift towards textual interpretation of labor laws in India, insulating statutory codes like the IRC, 2020 from historical judicial expansions while keeping legacy protections intact for pending litigation.

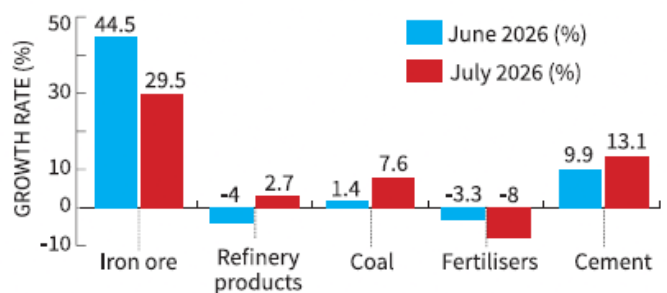
2. Core Sector Growth Slows to 5.4% in July 2026 as Fertilizer, Oil Output Falls

Key Highlights & Summary

- Growth in India's core industrial sectors slowed to 5.4% in July 2026 compared to 6% in June, driven by sharp decelerations in fertilizers, iron ore, and steel output.
- Fertilizer production experienced a major contraction of 8% in July 2026, dropping sharply from a contraction of 3.3% in June, primarily owing to deficient and patchy monsoon rainfall leading to reduced crop sowing.
- Output in natural gas and crude oil sectors continued to contract, while steel sector growth fell to 2.9% in July, marking its lowest expansion rate in 14 months.
- Despite the overall deceleration, July's 5.4% growth rate remained the second-fastest core industrial growth recorded in seven months.
- Coal sector output reached an 11-month high growth rate of 7.6% in July 2026, benefiting significantly from a low base effect due to a 12.3% contraction in July of the previous year.
- Cement production accelerated to 13.1% in July 2026, rising from 9.9% in June, demonstrating ongoing momentum in construction activities.

Sliding down

Core sector growth slowed to 5.4% in July 2026 compared with 6% in June. Iron ore, refinery products see biggest shifts

The July 2026 core sector data highlights a domestic economic recovery that remains uneven, influenced by seasonal monsoon deficits and persistent contraction in upstream energy sectors. While low base effects temporarily mask structural slowdowns in key inputs like steel and fertilizers, sustaining aggregate industrial output will require targeted infrastructure investments and stabilized agrarian demand.

3. EoI for Green AI Data Centre in Andaman and Nicobar Islands Withdrawn

Key Highlights & Summary

- The Andaman and Nicobar Islands administration has abruptly withdrawn an Expression of Interest (EoI) that sought feasibility proposals for establishing a private sector-led green artificial intelligence (AI) data centre.
- Issued on August 10 and cancelled shortly after due to undisclosed administrative reasons, the proposal aimed to deploy off-shore and marine data infrastructure around Little Andaman and Great Nicobar Island.
- Local indigenous Nicobarese populations on Great Nicobar Island were reportedly not informed or consulted regarding the data centre deployment, sparking concerns over tribal rights and land use consent.
- The draft master plan released for the island's comprehensive infrastructure development lacks any mention or integration of a green AI or data infrastructure vertical.

- The sea zones originally identified for the facility overlap with critical ecology, including wildlife corridors at Gandhi Nagar Bay and agricultural or biodiversity areas around Anderson Bay.
- The withdrawal occurs amid ongoing public protests by residents against a broader 91,000-crore mega infrastructure project slated for Great Nicobar Island.

Andaman and Nicobar administration withdraws call to develop 'green' AI data centre

The sudden withdrawal of the data centre proposal highlights the complex trade-offs between expanding frontier digital infrastructure and preserving fragile island ecosystems alongside indigenous tribal rights. Moving forward, sustainable regional development requires transparent stakeholder engagement, rigorous environmental impact assessments, and strict adherence to statutory tribal safeguards.

4. T.N. CM Seeks Fair, Equitable Treatment of Southern States

Key Highlights & Summary

- Addressing the 31st Southern Zonal Council meeting chaired by Union Home Minister Amit Shah at Mamallapuram, Tamil Nadu Chief Minister C. Joseph Vijay advocated for fair, equitable fiscal treatment respecting state autonomy.
- Emphasized that southern states account for over 30% of India's GDP and asked the upcoming Finance Commission to balance fiscal need with regional economic performance.
- Demanded legislative assurances from the Center to ensure well-performing states are not penalized through reduced parliamentary representation during post-census delimitation.
- Stressed the strict implementation of Supreme Court verdicts and tribunal awards regarding riparian rights in inter-state river management disputes like Cauvery and Mullaperiyar.
- Reiterated Tamil Nadu's long-standing demand for exemption from the National Eligibility cum Entrance Test (NEET), advocating admission to state medical courses based strictly on Class XII marks.
- Proposed joint Southern initiatives, including common economic-logistics corridors, maritime economy integration, and coordinated inter-state enforcement against narcotics trafficking.

5. Odisha Forms Panel to Examine Relocation of Villages from Satkosia Tiger Reserve

Key Highlights & Summary

- The Odisha government has constituted a high-level inquiry committee, headed by the Revenue and Disaster Management Secretary, to examine the relocation of villages from the Satkosia Tiger Reserve (STR).
- The panel was formed following allegations by local residents that they were forcibly evicted from their ancestral lands despite coexisting harmoniously with wildlife for decades.
- The committee is mandated to verify compliance with statutory provisions, including the Wildlife (Protection) Act, 1972, the Forest Rights Act, 2006, and National Tiger Conservation Authority (NTCA) guidelines.
- Scrutiny will focus on beneficiary identification, exclusion/inclusion errors, assessment of differential compensation, restoration of rights, and livelihood support, excluding Raiguda village which followed proper protocols.
- The committee has been directed to identify officials responsible for procedural irregularities or violations and recommend departmental and criminal action against them.
- Satkosia Tiger Reserve faces severe conservation challenges; its tiger population dropped from 12 in 2007 to just one in 2018-19, recording zero tigers in the 2022 census.

- **Article 21 & Article 48A:** Balances the fundamental right to life and livelihood of indigenous communities with the state's Directive Principle to protect environmental and wildlife ecology.

Conclusion

The inquiry into village relocations at Satkosia Tiger Reserve highlights the persistent challenge of balancing wildlife conservation with indigenous rights. Ensuring procedural compliance under the Forest Rights Act and NTCA guidelines remains critical to preventing forced evictions and ensuring sustainable, rights-based conservation strategies.

6. UGC Equity Rules Being Reconsidered: Centre to SC

Key Highlights & Summary

- The Union Government informed the Supreme Court that it is reconsidering the University Grants Commission (Promotion of Equity in Higher Education Institutions) Regulations, 2026.
- Notified on January 13, 2026, the equity regulations were stayed by the Supreme Court on January 29, which invoked Article 142 to revive the 2012 regulations until further orders.
- A three-judge bench headed by Chief Justice of India Surya Kant asked the UGC to file a comprehensive counter-affidavit within four weeks regarding the batch of petitions.
- The primary legal challenge targets Regulation 3(1)(c), which defines caste-based discrimination as discrimination on the basis of caste or tribe against members of SCs, STs, and OBCs.



- Petitioners contend that Regulation 3(1)(c) excludes general category students and faculty from protection against caste-based harassment, creating an unequal classification.
- The Supreme Court flagged concerns that the 2026 framework was "prima facie vague," lacked mechanisms to penalize false complaints, and omitted ragging from its scope.

Conclusion

The Centre's decision to review the 2026 UGC Equity Regulations highlights the complex challenge of drafting affirmative anti-discrimination frameworks without violating formal principles of legal equality under Article 14. Achieving inclusive higher education requires balanced, precise regulations that address systemic disadvantages while protecting all campus stakeholders against arbitrary misuse.

7. RWAs a Barrier: Govt May Let High-Income Households Compile Own Spending Data

Key Highlights & Summary

- The Ministry of Statistics and Programme Implementation (MoSPI) plans to adopt "diary-based data collection" for high-income households in gated communities for the upcoming Household Consumption Expenditure Survey (HCES) starting mid-2027.
- Resident Welfare Associations (RWAs) restricting entry to survey staff and rising non-response rates among affluent urban households have prompted MoSPI to pilot self-reporting mechanisms.
- Data shows urban non-response rates rose sharply to 9.8% in the 2022-23 HCES, compared to 2.8% in the 75th NSS round, with non-response among the most affluent urban residents reaching 11%.
- Under the diary method, selected households will record their monthly expenditures on 405 goods and services via an online portal or logbook as transactions occur.
- The diary approach minimizes memory-based "recall errors," which frequently affect traditional door-to-door field interviews.
- MoSPI faces the methodological challenge of stitching together disparate data sets gathered through traditional interviews and self-reported online diaries.

MoSPI's proposed shift toward diary-based self-reporting addresses urban access limitations and reduces recall error, though integrating self-reported metrics with field-surveyed data requires rigorous statistical calibration to maintain survey integrity.

8. Union Cabinet Clears High Court Bench for Ladakh

Key Highlights & Summary

- The Union Cabinet, led by Prime Minister Narendra Modi, approved the establishment of a permanent sitting bench of the High Court of Jammu and Kashmir and Ladakh in the Union Territory of Ladakh.
- Announced by Union Home Minister Amit Shah, the move aims to significantly improve access to justice for residents living in geographically challenging and remote areas of Ladakh.
- The new bench becomes the third location of the common High Court, which currently operates out of principal sittings in Srinagar and Jammu.
- Ladakh Lieutenant Governor Vinai Kumar Saxena welcomed the decision as a historic step toward ensuring timely judicial delivery and legal services.
- The decision addresses a long-standing regional demand for localized judicial infrastructure, reducing travel time and costs for litigants.
- The announcement coincides with ongoing deliberations between the Ministry of Home Affairs and local representatives, including the Leh Apex Body and Kargil Democratic Alliance, regarding constitutional safeguards.

The establishment of a High Court bench in Ladakh marks a significant development in judicial administration, bringing higher judiciary services directly to the high-altitude region and reinforcing institutional governance alongside regional development initiatives.

9. English Indigenous or Foreign Language? Supreme Court for Examining Constitutionality

Key Highlights & Summary

- The Supreme Court questioned the legal classification of English as a "non-indigenous" or non-native language under the CBSE's three-language policy framed under the National Education Policy (NEP).
- A three-judge bench, headed by Chief Justice of India Surya Kant, noted that given the deep historical roots of English in Indian society, its constitutionality under school curricula warrants judicial examination.
- The court asked CBSE whether the implementation for current Class 6 students could be deferred to next year, citing gaps in infrastructure and teacher readiness across schools.
- Additional Solicitor General Aishwarya Bhati clarified that English holds official constitutional status and cannot be treated as a purely foreign language, though it differs from native regional tongues.

- Bench members expressed reservations over terms like "native," suggesting "indigenous" is more appropriate while warning that colonial terminology obscures the contemporary linguistic realities of India.
- The Supreme Court highlighted structural asymmetries between CBSE and State Board schools, emphasizing the severe shortage of B.Ed-qualified teachers for languages like Sanskrit.

11. Centre's Fiscal Outlook Faces Geopolitical, Revenue Risks

Key Highlights & Summary

- Controller General of Accounts (CGA) data shows the Centre's gross tax revenues (GTR) grew by only 3.7% in Q1 2026-27 due to subdued personal income tax (PIT) and GST receipts following 2025-26 tax rate rationalizations.
- West Asian geopolitical conflicts and volatile global crude oil prices led to excise duty cuts on retail fuel, causing Union excise duty collections to contract by 22.4% in Q1 2026-27.
- To offset tax shortfalls, the government introduced the Health Security se National Security (HSNS) Cess from February 1, 2026, increased windfall taxes on fuel exports, and raised import duties on precious metals.
- Non-tax revenue buffers, supported by strong RBI dividend transfers, contributed 37% of net revenue receipts in Q1, helping absorb a 37.4% surge in major subsidies.
- First-quarter tax devolution to states contracted by 19.5%, though overall assignment is expected to align with the Sixteenth Finance Commission's (FC16) 41% divisible pool mandate.
- First-quarter fiscal deficit stood at 18.2% of the annual budget target, with full-year fiscal deficit and debt-to-GDP ratios projected near 4.6% and 55.8%, respectively.

12. The Vanashakti Verdict is Balanced and Pragmatic

- In *Vanashakti vs Union of India* (July 29, 2026), the Supreme Court clarified environmental clearance (EC) rules, reiterating that prior EC remains a mandatory statutory requirement.
- The Court held that project proponents who started operations without prior EC cannot seek regularization under expired 2017 notifications or the struck-down 2021 Office Memorandum.
- A distinction was established between administrative office memorandums, which cannot override prior EC mandates, and statutory notifications issued under parent environmental acts.
- The judgment recognized that the Central Government retains statutory power under Section 3 of the Environment (Protection) Act, 1986, to frame fresh mechanisms if necessary in public interest.
- The Court noted that wholesale demolition of investment-heavy, environmentally acceptable projects may not serve public interest, leaving room for a structured statutory solution.
- Any potential future regularization scheme must remain a strict one-time opportunity featuring comprehensive environmental damage assessments, remediation, and strict compensation conditions.
